## PRIVACY POLICY - Privacy Statement (art. 12 – GDPR)

In accordance with Chapter III of **European Regulation, n. 679/2016** and subsequent amendments (hereinafter, the "Privacy Regulation"), we inform you, in the capacity of data subject, that the personal data that you provided, or which was otherwise lawfully collected as part of our activities (hereinafter the "Data") are processed in compliance with the Privacy Regulation and the obligation of confidentiality that underpins the activities of **MAC PORT Macchine Operatrici Portuali S.r.l.**

The Data may be collected from the subject or from other sources (e.g. archives, family members, etc.) The collection can also take place by electronic means, and the data may subsequently be processed by automated or manual means.

The data are processed in compliance with the applicable regulations on security, with reference to the text of the Privacy Regulation in its entirety. The information systems and software are configured to minimise any use of personal and identifying data that is not necessary for the purposes of processing set out below.

The data are processed by **MAC PORT Macchine Operatrici Portuali S.r.l.** for the following purposes:

1. Compliance with statutory and/or regulatory obligations (e.g. contractual or tax obligations) or to establish or defend a legitimate right in a court of law.

Consent to processing of your data is necessary in order to carry out the activities relating to the above purposes. Accordingly, if you refuse consent, it will not be possible to proceed with the specific processing. To correctly accomplish the above purposes, the collected data may be accessed by the controller, the data processing officer, the data protection officer, and authorised processors of the data. The updated list of these subjects can be requested from the controller.

The data collected and processed for the above purposes shall be transmitted to the following categories of recipients:

- **Software Houses**
- **Accountants**
- **Banks**
- **Control and certification bodies**

The criteria that determine how long the data is stored are dependent on statutory obligations, with a minimum retention period of 10 years from the acquisition of the data. This period may be exceeded in cases where the data are strictly necessary for audits carried out by national inspection authorities. In some cases the data are retained for a period of 5 years from acquisition in the paper archives of **MAC PORT Macchine Operatrici Portuali S.r.l.**

We inform you that you can assert the rights of Chapters II and III of Regulation EU 2016/679, including the right to withdraw your consent at any time (art. 7 – Chapter II), the right to obtain from the controller confirmation as to whether or not personal data concerning you are being processed, and the right to lodge a complaint with the supervisory authority (art. 15 – Chapter III), the right to obtain from the controller the rectification of inaccurate personal data concerning you (art. 16 – Chapter III), the right to obtain from the controller the erasure of personal data concerning you (art. 17 – Chapter III), the right to obtain from the controller restriction of processing (art. 18 – Chapter III), the right to receive the personal data concerning you in a structured format so as to be able to transmit those data without hindrance to another controller (art. 20 – Chapter III) and the right to object at any time, on grounds relating to your particular situation, to the processing of personal data concerning you (art. 21 – Chapter III).
